Step-1 Registration

- For Registration and Sale of draft O&M Agreement as per Clause 1.2.1(a) of RFP, please download the **Registration Form**.
- List of Nominated Entities: The prospective Bidders may provide a list of Nominated Entities in the Registration Form (please note that providing list of Nominated Entities is not a mandatory requirement)
- The prospective Bidder shall fill the Registration Form and submit the same to the email id: edkid@aai.aero. Along with the Registration Form, the prospective Bidders shall also submit the following documents to AAI duly completed as per the requirements of RFP and submit to edkid@aai.aero :
 - Non-Disclosure Undertaking in the format provided in Appendix IX of the RFP
 - Power of Attorney for Signing Non-Disclosure Undertaking in the format provided in Appendix X of the RFP
 - Proof of payment of non-refundable fee as required under Clause 1.2.1 (c)

Step-2 AAI Registration Certificate

- On receipt of the documents highlighted in Step-1, AAI shall verify the documents and issue a "AAI Registration Certificate" to the prospective Bidder. The Bidder would be required to submit the AAI Registration Certificate as part of their Bid.

Step-3 Access to Draft O&M Agreement

- On completion of Step 2, the prospective Bidders can obtain a copy of Draft O&M Agreement from the office of ED(KID) as per the provisions of the Clause 1.2.2 of the RFP.


Step-4 Access to Project Site and Data Room
